Mayor Hamblin requested that the record show all Councilmembers are present except for Councilor John Phelps. Mayor Bryce Hamblin led the Pledge of Allegiance and Councilor Reece Hadlock offered the invocation.

#### ITEM #6: OPEN CALL TO THE PUBLIC

Terry Shove stated that basketball has started, and St. Johns has joined in. New LED lights are being installed in the dome and the turf has been rolled up. The mobile meat truck has arrived.

Sandra Howard asked for council to consider changing the speed limit on School Bus Rd. due to nobody paying attention to wildlife. She witnessed a white truck get in a wreck with a deer and could not get people to slow down and pay attention.

#### ITEM #7: PUBLIC HEARING

A. DISCUSSION AND POSSIBLE ACTION TO CONSIDER AN APPLICATION FROM JESSE ROGERS FOR A CONDITIONAL USE PERMIT #CU2021-8 TO ALLOW AN RV PARK TO BE CREATED IN A COMMERCIAL ZONED AREA AT THE CORNER OF WEST CENTRAL AVE AND SOUTH RIVER ROAD KNOWN AS PARCEL 104-20-001A.

Vice-mayor Steve Erhart made a motion to go into the Public Hearing [at 6:08 p.m.] Councilor Debra Seeley seconded; all were in favor, motion carried unanimously. 6-0

#### COUNCILOR MARSHA TUCKER THEN RECUSED HERSELF

Brett Rigg reported that the Planning and Zoning Commission met on July 13, 2021 and denied the conditional use permit. Commissioners were concerned about safety and Brenda Ciminski abstained from the vote. The code is clear that from the day it is denied that it can be appealed within 15 days. Section 18.84.070 states that if it goes to public hearing council can approve, approve with conditions, or deny the decision is final for one year.

Mayor Bryce Hamblin asked for clarification that the commission denied, correct?

Mr. Rigg replied that it was denied three ayes and one nay.

Mr. Rigg stated that council can designate the size of vehicle, noises, lights, purposed use and that RV Parks require a five-to-six-foot solid fence, twenty-foot RV spaces, gravel, four percent recreational area, fire suppression and sanitation.

Mayor Hamblin asked what the definition for adjacent landowner is?

Mr. Rigg stated it means nearby but not necessarily touching.

Adam Buck attorney for Jesse Rogers provided a presentation for the planned RV Park.

Mr. Buck presented a second presentation stating that the property is zoned as a C-1 and Arizona Department of Transportation "ADOT" states that access is to be on River Rd. asking that Council to approve the conditional use permit.

Jesse Rogers stated that he did go and talk to Candace with ADOT stating that I do need to get a traffic engineering done which is in the process.

Mr. Buck read a letter on behalf of John Udall stating that Mr. Udall endorses the project and is excited to see the project.

Mayor Hamblin asked if there is an age requirement for the RV Park?

Mr. Rogers replied that he has not decided on that yet but plans to have strict rules.

Melissa McNeill stated that the concern is from the hill on River Rd to Highway 260. Concerned about wrecks and not being able to see over the hill. The Harris's were approved so my question is a traffic study required for every RV Park or just Mr. Rogers and do businesses have to do that same?

Britney Reynolds replied that the Harris's were approved with conditions one of those conditions is to get a traffic study done.

Matt Mears stated that each permit is a case-by-case bases. Businesses have different requirements that must be met.

George Pichel stated that people rarely do the speed limit on River Rd. If you're not careful when you come over the hill in the winter, you can slide before reaching the stop sign and worried about plowing through an RV. Has the town thought about water and sewage usage and how that will impact the system?

Mr. Mears replied that capacity wise there is not a concern for the sewage.

Gary Eagar states that if an RV Park is done right, they can be really nice. Some RV's cost more than a home and you meet some really nice people in parks.

Mr. Rogers states he would like it to be very similar to the Bear Paw RV Park lots will be 35ft wide and 65ft to 85 ft long.

Vice- mayor Steve Erhart asked when the study is supposed to be done?

Mr. Rogers sated that it should be done in a few weeks.

Sally Simmons states she is not against anyone bettering themselves or their family. There has been a death on that hill of River Rd., and it is dangerous. Concerned with fire season and fire pits, concerned about kids and extra traffic, and what will happen to with all vegetation and what is the timeline of the project.

Councilmember Debra Seeley asked about emergencies if there is a secondary exit?

Mr. Rogers stated that he hopes to start in the spring and be done by the fall don't plan to drag it out. I plan to keep most of the vegetation the code does require a 5ft to 6ft fence hoping to do a wood fence and can investigate a secondary entrance for emergencies.

Brenda Ciminski stated that she is there representing her father. Mrs. Ciminski states that 10 to 12 years ago when that property was rezoned to commercial at a Planning and Zoning meeting the condition was to come off Highway 260 would like to see that still as one of the conditions.

Shawna Murphy Chair of the Planning and Zoning Committee states that the commission was not against the RV Park but that it was denied because of safety concerns. At the Planning and

Zoning meeting we asked Mr. Rogers to do a traffic study and he stated he would not so therefore it was denied.

Councilor Nicoll stated maybe the Town needs to look into some speed bumps or yield signs since this will potentially bring in more traffic

Mayor Hamblin stated that Mr. Rogers cannot control speeders and if kids are playing in the street that is the parents' fault. Mayor Hamblin continued stating he would like to see a traffic study done with recommendation from ADOT.

#### Mayor Bryce Hamblin Recused himself

Rachael Williams stated that the existing tiny homes plus the five spaces on the back part of the property it would not be a huge RV park but a part of the tiny homes. I have not found in the code that parks aren't allowed on Main St. We have built a great business and we violated the code on accident, then applied for a permit, were denied at a Planning and Zoning (P&Z) meeting and felt like they were not heard.

Councilor Marsha Tucker asked why Planning & Zoning denied the permit?

Ms. Williams stated that she was not sure told because it was on Main St and RV parks are not allowed. Bruce Ray told Tysseling's that they could do what we wanted because it was commercial property.

Brett Rigg read the draft minutes from the P&Z meeting.

Vice-mayor Erhart stated that in section 18.60 of the town code that engineered plans are required. Do you have engineered plans and why not do more tiny homes?

Ms. Williams stated that she believes there are engineered plans for the tiny homes and doing RV spots because there seems to be a need for them. Tiny homes are time consuming to maintain.

Joe Sitarzewski stated that the P&Z commissions main concern is RV Parks on Main St. It's not an RV park there is not enough room per code for all the recreation space, the tiny homes, and RV spaces. Also, the RV spaces were built with no permits or inspections.

Sue Phelps stated that she doesn't see a problem with an RV park on Main St. The business is doing great why not let them keep thriving.

Shawna Murphy chair for P&Z stated the permit was submitted when the project was already completed. We did not receive any documents for the permit no site plans, engineering etc. and that is not a good fit for the area.

Councilor Reece Hadlock asked if there is supposed to be inspections?

Mr. Mears replied that yes there always has to inspections.

Ms. Williams stated that her dad Tom Tysseling is an electrician and didn't know that they had to get an inspection.

Kate Brady, finance director stated that the tiny homes are part of transient lodging at 6% sales tax RV space rentals, do not fall under the transient lodging.

Danielle Hommel with Better World Barbecue gave an update on the "Knock the halls" fundraiser. ## F. DISCUSSION AND UPDATES ON LITTLE COLORADO MEATS USDA MEAT PROCESSING FACILITY

Terry Shove stated that we started with \$100k from lending from the Towns of Eagar, Springerville, St. Johns and Apache County to create a revolving loan.

Karalea Cox stated that Little Colorado Meats was formed in response to challenges in Apache County. Funding assistance from USDA Rural Development to construct a USDA inspected meat processing facility. Out mission is to be harvesting and processing to local ranchers. Ranches can have meat processed and take back with there label and sell themselves they can take it across state lines because it is USDA inspected. If ranchers don't want it back Little Colorado Meats will buy that meat 30% above current carcass price.

Ms. Cox continued that they are looking into supplying meat to local food banks, hospital, schools, some retail at restaurants and grocery stores and will also do online orders with delivery. Economic impact 1<sup>st</sup> year with \$2.2 million investment and wages and amount of meat processed and sell about 170,000 pounds estimated gross increase for rancher's estimate is almost \$5 million. This month construction continues and March employee interviews, training, precontract, and scheduling. April equipment and unit installation then in May official opening.

Councilor Phelps asked how many ranchers are wanting to be involved?

Ms. Cox stated that the initial survey back in 2018 had over 500 produces big and small express and interest. Over time the interest has grown, and we have a waiting list.

Vice-mayor Erhart asked you say local and our area what is our area?

Ms. Cox stated we stuck to Apache County and based the data off Apache County that does include the reservation only in Apache County. We are expecting to get some ranchers from other areas like Navajo and Catron County.







SUBJECT: ALTERNATIVE EXPENDITURE LIMITATION "HOME RULE

**OPTION**"

In 2018 the voters of Eagar approved the continuance of the Home Rule Option. We are currently operating under voter approved alternative expenditure limitation until the fiscal year 2022-2023. The voter approval we are seeking, if passed and adopted, will cover the fiscal years 2023-2024, 2024-2025, 2025-2026, and 2026-2027.

#### BACKGROUND OF THE HOMERULE OPTION

In the summer of 1980 the State Legislature referred to the voters a constitutional amendment designed to limit the annual expenditures of all Arizona cities and towns by a formula. To determine the expenditure limitation, the State established 1979-1980 as a "base year.' Added to this base year is an adjustment for population growth and inflation.

The Base Year: The base year is critical because it is the foundation upon which all-future budget adjustments are made.

If voters passed Home Rule in the up coming election: It will not affect balancing the budget. Eagar is already required by State law to have a balanced budget. What it will do is allow the Town to spend the general fund monies it already has for programs and services its citizens today feel are essential. The general fund is what is used to pay for police, parks, and general government services.

If voters reject Home Rule: It means that Eagar must set its annual budget under a State-imposed formula. This formula penalizes Eagar wherein inflation and old population figures do not reflect current needs and demand for services. Failure means the State imposed expenditure limitation will continue to limit how funds are spent.

#### WHAT HOME RULE IS-

- Home Rule is the option under which citizens and the Town Council adopts an annual budget for their Town "at home" rather than by using the State-imposed limitation
- Home Rule is not new for Eagar, Town voters have approved this local option since 2006, this issue must be re-submitted to Town voters every four years
- Eagar is limited by the "base year" of 1979-80 used by the State Legislature to determine the expenditure limitation

- Without the Home Rule local option, Eagar conforms to the State imposed expenditure limitation. Currently we raise more revenue than we legally can spend
- The Home Rule Option means that local citizens will control how existing revenues are allocated in setting the Town budget, using local needs and priorities as seen by the community rather than by a State-imposed formula
- The Home Rule Expenditure Limitation Option enables the Town to expend the revenues generated. Under this option the Town will create a balanced budget with community input, which is published and audited
- A "Yes" vote means that you are for the Home Rule option, and for setting a balanced Town budget locally though your elected representatives
- A "No" vote means that you are against the Home Rule option and would prefer to see the Town operate under the State-imposed budget limitation

#### WHAT HOME RULE ISN'T-

The Home Rule Option does not empower the Town Council to create new and additional taxes, nor does it enable the Town to spend beyond the revenue it currently receives.

#### 1. What is the origin and purpose of expenditure limitation reports?

On June 3, 1980, Arizona voters approved <u>Arizona Constitution</u>, <u>Article IX</u>, §20, prescribing an expenditure limitation for each city and town. The expenditure limitation's purpose is to control expenditures of local revenues and limit future increases in spending to adjustments for inflation and population growth. Cities and towns were subject to the expenditure limitation effective in the fiscal year following the first regularly scheduled governing board member election after July 1, 1980.

Arizona Revised Statutes (A.R.S.) §41-1279.07 requires the Auditor General to prescribe a uniform expenditure reporting system (UERS) for all political subdivisions subject to the constitutional expenditure limitations Article IX, §20, prescribed. As that statute required, our Office developed the UERS forms to provide detailed instructions for completing and submitting expenditure limitation reports.

#### 2. How is the expenditure limitation determined for a city or town?

The Constitution required the Economic Estimates Commission (Commission) to establish for each city and town a base limit from actual expenditures of local revenues for fiscal year 1980. Each year, the Commission calculates the constitutional expenditure limitation for all cities and towns by adjusting their base limits for any voter-approved permanent base adjustments or annexations, changes in population, and inflation since the base year.

#### 3. Where can a city or town obtain its constitutional expenditure limitation?

Cities and towns can obtain constitutional expenditure limitations from the Arizona Department of Revenue's <u>Economic Estimates Commission</u> web page. The Commission should notify cities and towns of their actual expenditure limitations by April 1 for the following fiscal year.

#### 4. Are all expenditures subject to the limitation?

No. The expenditure limitation applies only to expenditures of local revenues as defined by Arizona Constitution, Article IX, §20(3)(d). Generally, local revenues include all monies received by or for the account of the city or town; however, the Constitution excludes some monies such as grants and aid from the federal government and certain revenues received from the State from the local revenues definition. For a detailed explanation of expenditures not subject to the limitation, see the instructions for UERS forms—part II. In addition, see the exclusions (part II) FAQs for further discussion of expenditures subject to the limitation.

#### 5. What is the penalty for exceeding the expenditure limitation?

In accordance with <u>A.R.S. §41-1279.07(H)</u>, a city or town that exceeds its expenditure limitation without authorization will have the following amount of state income tax (urban revenue sharing monies) withheld based on the percentage of the excess expenditures:

- If the excess expenditures are less than 5 percent of the limitation, the amount withheld is equal to the excess expenditures.
- If the excess expenditures are between 5 percent and 10 percent of the limitation or are less than 5 percent of the limitation but it is at least the second consecutive instance of excess expenditures, the amount withheld is equal to three times the excess expenditures.
- If the excess expenditures are equal to 10 percent or more of the limitation, the amount withheld is equal to five times the excess expenditures or one-third of its allocation of state income tax. whichever is less.

Before state monies are withheld, the Auditor General must hold a hearing to determine if the city or town has exceeded the expenditure limitation without authorization. To ensure due process, the city or town representatives are invited to attend and participate in this hearing. The State Treasurer withholds the penalty in the fiscal year following the Auditor General's hearing.

## 6. Are there any provisions that allow a city or town to authorize expenditures in excess of its constitutional expenditure limitation?

Arizona Constitution, <u>Article IX, §20</u>, includes provisions that allow cities and towns to authorize expenditures in excess of their expenditure limitations for expenditures a natural or manmade disaster directly necessitates. The governing board and possibly voters must approve the excess expenditures. See the instructions for UERS form—part I for detailed information on these constitutional provisions.

The Constitution also provides cities and towns several voter-approved options to alter their expenditure limitation. These options include exceeding the expenditure limit for 1 year (one-time override), permanently adjusting the base limit used to calculate the expenditure limitation (permanent base adjustment), or a temporary alternative expenditure limitation (home rule). See the voter-approved expenditure limitations FAQs for detailed information on these constitutional provisions.

#### 2023-2024 EXPENDITURE LIMITATION CALCULATION

One of the most important steps in determining whether you will need to seek an alternative to the state-imposed limitation is the calculation of your 2023-2024 expenditure limitation. This calculation will be accomplished for you by the Economic Estimates Commission (EEC). The EEC must provide you with a preliminary limit by February 1 and a final figure by April 1.

Because these dates may not be in time for you to determine whether you must seek an alternative to the state-imposed limitation, we have provided the formula for estimation of your state-imposed limitation for 2023-2024.

Before you proceed to the actual calculation, let us caution you on a couple of points. Population figures used in your calculations must be from the Department of Administration. We do not have current published projections. To obtain the projections needed, contact Jim Chang, Department of Administration (see address and phone number on page 20). The population figures provided will include estimates and projections. In projecting your expenditure limitation for fiscal year 2023-2024, you will start with the latest population estimate available from the Department of Administration.

We have provided a listing of DES 1978 populations as well as the Economic Estimates Commission (EEC) 1979-80 Base Limitations necessary for the calculation of your expenditure limitation on the following page.

In addition, the percent change in the GDP implicit price deflator provided in the calculation format below may change between when this Guide is prepared and the time you are actually doing the calculations for your submission to the Auditor General's Office. The changes are usually provided to cities and towns in March and September from the Arizona Department of Revenue. Accordingly, the deflator figure noted below should only be used for this calculation. We now suggest that you proceed with the calculation to estimate your 2023-2024 expenditure limitation by inserting the appropriate information and multiplying or dividing as directed:

This 2023-2024 expenditure limitation figure is only an estimate due to the possible adjustments in your population figures and the percent of change in the GDP deflators. It should, however, assist you in determining whether your community wants or needs to seek an alternative to the state-imposed limit.

#### **RESOLUTION NO. 2022-03**

A RESOLUTION OF THE TOWN OF EAGAR, ARIZONA PROPOSING AN EXTENSION OF THE ALTERNATIVE EXPENDITURE LIMITATION.

WHEREAS, the Arizona State Constitution permits the submission to the voters of a city or town of an alternative expenditure limitation; and

WHEREAS, the voters of the Town of Eagar, Arizona in 2018 adopted an alternative expenditure limitation; and

WHEREAS, the Town Council of Eagar, Arizona after two public hearings, has determined that an extension of the alternative expenditure limitation is necessary for the Town of Eagar, Arizona.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of Eagar, Arizona that the following alternative expenditure limitation be submitted to the voters of the Town of Eagar, Arizona.

Shall the following be adopted by the Town of Eagar, Arizona as an alternative expenditure limitation:

"The Mayor and Common Council of the Town of Eagar, Arizona shall annually, as part of the annual budget adoption process, adopt an alternative expenditure limitation equal to the total amount of budgeted expenditures/expenses as it appears on the annual budget as adopted by the Council to apply to the Town of Eagar, Arizona for each of the four fiscal years immediately following adoption of the alternative expenditure limitation. The alternative expenditure limitation shall be adopted each year after a public hearing at which the citizens of the Town of Eagar, Arizona may comment on the proposed alternative expenditure limitation. No expenditures may be made in violation of such alternative expenditure limitation, nor may any proposed expenditures be in excess of estimated available revenues, except that the Mayor and the Common Council may, by three-fourths vote, declare an emergency and suspend the alternative expenditure limitation. The suspension of the alternative expenditure limitation shall be in effect for only one fiscal year at a time."

# ALTERNATIVE EXPENDITURE LIMITATION (Home Rule Option) DETAILED ANALYSIS

Pursuant to the Arizona State Constitution, the Town of Eagar as authorized by Resolution # 2022-03 passed on March 17, 2022, will seek voter approval to adopt an alternative expenditure limitation (Home Rule Option) to apply to the Town of Eagar for the next four years beginning in 2023-2024

Under a Home Rule Option if approved by the voters, the town estimates it will be allowed to expend approximately \$7,309,554 in 2023-2024, \$6,748,238 in 2024-2025, \$6,713,464 in 2025-2026 and \$6,780,599 in 2026-2027.

With approval of the Home Rule Option, the town will utilize the expenditure authority for all local budgetary purposes including general government, police, fire, parks, facilities, fleet, street construction, street maintenance, water, sewer and grant matching. We estimate that the expenditures for the next four years under the Home Rule Option will be as follows:

In determining the revenue sources to fund the authorized additional expenditures under the alternative expenditure limitation, it is assumed that the federal, state and local revenues received by the city/town will continue to be available in 2023-2024 as they have for the past 69 years. Their continued availability is also assumed for the next three consecutive years following 2023-2024.

Any and all dollar figures shown in this analysis are estimated figures only and are based upon information available at the time of preparation of this report. The budgets and actual expenditures in any given year may be more or less than the figures noted above depending on available revenues. The actual expenditure limitation for each fiscal year shall be adopted as an integral part of the budget for that fiscal year.

# ALTERNATIVE EXPENDITURE LIMITATION (Home Rule Option) SUMMARY ANALYSIS

(The voters of the Town of Eagar in 2018 adopted an alternative expenditure limitation (Home Rule Option). The purpose of this election is for the continued use of the Home Rule Option.)

Pursuant to the Arizona State Constitution, the Town of Eagar seeks voter approval to adopt a Home Rule Option to apply to the town for the next four years beginning in 2023-2024. Under a Home Rule Option if approved by the voters, the town estimates it will be allowed to expend approximately \$7,309,554 in in 2023-2024, \$6,748,238 in 2024-2025, \$6,713,464 in 2025-2026 and \$6,780,599 in 2026-2027.

With approval of the Home Rule Option, the town will utilize the expenditure authority for all local budgetary purposes including general government, police, fire, parks, facilities, fleet, street construction, street maintenance, water, sewer and grant matching.

Under the state-imposed limitation the town estimates it will be allowed to expend approximately \$4,196,431 in 2023-2024, \$4,343,640 in 2024-2025, \$4,492,972 in 2025-2026 and \$4,647,953 in 2026-2027 for the operation of your local government. These expenditure estimates include expenditures of constitutionally excludable revenues.

The amount of revenue estimated to be available to fund the operation of your city/town government is \$7,443,122 in 2023-2024, \$6,781,113 in 2024-2025, \$6,828,120 in 2025-2026 and \$6,881,402 in 2026-2027. These revenue estimates are the same under the Home Rule Option or the state-imposed expenditure limitation.

Any and all dollar figures presented in this summary are estimates only and are based upon information available at the time of preparation of this analysis. The budget and actual expenditures in any of the four years may be more or less than the expenditures noted above depending on available revenue.

If no alternative expenditure limitation is approved, the state-imposed expenditure limitation will apply to the town.

#### ORDINANCE NO. 2022-01

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF EAGAR, ARIZONA AMENDING THE TOWN CODE BY REVISING TITLE 17, SECTION 17.04.050 MINOR LAND DIVISIONS.

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF EAGAR, ARIZONA AS FOLLOWS:

WHEREAS, the Mayor and Council has determined that it is in the best interest of the health, safety and welfare of the Town of Eagar and its residents, that Title 17, Section 17.04.050 Minor Land Divisions, of the Town code be revised; and

WHEREAS, the Mayor and Council desires to amend the Town code by revising Title 17, Section 17.04.050 Minor Land Divisions as shown on "Exhibit A" attached as part of this ordinance; and

WHEREAS, it is necessary for the preservation of the peace, health and safety of the Town of Eagar, Arizona, an emergency is declared to exist, and this ordinance shall become immediately operative and in force from and after the date of posting hereof.

NOW THEREFORE LET IT BE ORDAINED by the Mayor and Town Council of the Town of Eagar, Apache County, Arizona, that the town code is hereby amended as shown on Exhibit "A"

#### Exhibit "A"

#### 17.04.050 Land divisions, combination, or recombination.

A. In the minor divisions of land in terms of A.R.S. Section 9-463.02 and Section 17.04.020 of this chapter, land or lands that are proposed to be divided, combined or recombined (this includes approved platted subdivisions when such lots in a subdivision are being combined or recombined) for purposes of sale or lease into three or fewer lots or parcels do not result in a "subdivision" or "subdivided lands" as defined in A.R.S. Section 9-463. Each lot or parcel shall comply with minimum applicable town zoning requirements and have legal frontage. Proposed minor land divisions that have legal frontage on a town street/road right-of-way (ROW) that has not been accepted into the town's road system and maintained by the town may be considered for approval with the following conditions being met:

1. The undeveloped street/road ROW may be used by the property owner (applicant) as a driveway to the applicant's property if:

a. The applicant purchases and posts signs where identified by the Public Works Director on the undeveloped street/road ROW stating the following: "THIS ROAD IS USED AS A PRIVATE DRIVEWAY AND IS NOT TOWN MAINTAINED. THE DRIVEWAY MAY NOT BE ACCESSIBLE DURING SEVERE WEATHER CONDITIONS, USE AT YOUR OWN RISK". The minimum size of the signs shall be 9 square feet (3X3); the colors black lettering on yellow background.

b. The applicant and/or their successor will be responsible for the maintenance and or replacement of the signs for any reason that may cause the signs to be damaged or unreadable.

2. A document provided by the town and signed by the applicant agreeing to the following provision will be recorded with the Apache County Recorders Office (with the applicant paying the recording fees) and attached to the deeds of all newly created parcels informing current and future property owners of their associated responsibilities for any and all maintenance of the driveway over town right of way to their property (ies) to include any and all signage. This document shall also state the following: "at the time of execution of this document the town has no plans in the foreseeable future to do any road improvements to the street/road within this ROW, described as \_\_(Identify the road/street ROW)\_\_\_\_ and will only construct/upgrade a street/road at a time when the town doesns it is in the best interest of the

town and it is financially feasible. Nothing in the Code or this agreement will preclude current or future property owners from participating with the town in the future to bring the street/road within the identified ROW that fronts their property to town standards. If at any time the property owner(s) on their own improve the street/road within the ROW to town standards, the town would at that time consider accepting the street/road for maintenance into the town's road system. The property owner shall indemnify and hold harmless the town from any and all claims and lawsuits including attorneys fees and costs that shall arise out of the use of the street/road ROW for its intended purpose. This document is no longer in effect once this section of the street/road within the ROW has been brought up to town standards and it is accepted into the town's road system. If the property served by this driveway is sold while this agreement is in effect the prior owner remains liable for the maintenance and the liability until a new document is recorded wherein the new owner of record agrees to the preceding stipulations for maintenance and liability.

- 1. A private easement with a minimum width of 30 feet.
- 2. Public roads to be maintained by the Town of Eagar shall be constructed to the Town of Eagar Subdivision Ordinance Design Standards and then adopted or accepted by the Town of Eagar prior to sale of any of the divided lots.
- 3. Any lot proposed to be created through the minor division of a parcel shall not be sold until a recorded deed and survey map showing the (split) division has been approved by the Community Development Department as complying with all applicable provisions of this section.
- B. Purpose. The purpose of this section is to provide a process to divide, combine or recombine land into, three or fewer lots, tracts, parcels, sites or divisions with a level of review to ensure the division, combination or recombination of land complies with zoning ordinances, zoning map and does not constitute a subdivision as defined by A.R.S. Section 9-463.02. This section is not intended to prohibit or prevent the division, combination or recombination of land as authorized and permitted by the Arizona Revised Statutes and the town of Eagar zoning and subdivision ordinance.

- C. Applicability. The provisions of this section shall apply to all divisions, combinations or recombination's of land not considered a subdivision located within the incorporated boundary of the Town of Eagar.
- D. Application. A minor land division, combination or recombination application shall be filed with the Community Development Department on a form provided by the Community Development
   Department.
  - Submittal and Fee.
- a. Prior to the recordation of a deed dividing land into three or fewer parcels of land or combining or recombining three or two parcels of land into one parcel, for the purpose of sale, lease, or transfer of ownership, the owner shall submit a minor land division, combination or recombination application to the Community Development Department.
- b. The processing fee is set by the town of Eagar council by resolution. If application is made after the deed is recorded, the processing fee will be doubled.
- 2. Survey Map. A registered land surveyor (R.L.S.) shall prepare the legal descriptions and map. The map shall be of a format acceptable to the county recorder (see A.R.S. Section 11-481) and shall include:
  - a. A north arrow;
  - b. The boundaries of the section (or portion thereof) within which the minor land division lies;
- The boundary lines of the minor land division and the lots within it, including their bearings and distances;
  - d. Location and width of all easements within and bordering the minor land division;
  - e. Width of easements and town accepted roads bordering the property.
- E. Review Criteria. The deed and survey map shall conform to the requirements of all the applicable town zoning code. In addition:
- 1. The design, shape, size, and orientation of the tracts should be appropriate for the use, which the division is intended, and to the character of the area in which they are located,
- 2. If a new street is created in the division of lots, parcels or lands, then by law is a subdivision and must conform to Section 17.04.040.

- F. Administrative Review. To approve a minor land division, combination or recombination (including approved platted subdivisions when such lots are being combined or recombined) the Community Development Department must find the following conditions exist:
- 1. Ownership of property being split, combined or recombined is demonstrated through a deed or other acceptable documents showing ownership and legal access to the parcel.
- 2. The newly created parcels or parcel when combined or recombined shall meet minimum development standards required by the Town Zoning Code.
- G. Action by the Town Community Development Department. Upon receipt of the submitted documents, the town Community Development Department shall review them to determine their completeness. If the application is complete, it shall be date stamped showing the working day it arrived complete. If the submitted documents and information are found to be incomplete or insufficient, the applicant shall be notified of the deficiencies and informed the application will not be formally accepted for processing until the missing items are submitted. Upon receipt of the completed application, the town planning and zoning department shall:
- 1. Distribute the submitted application for review and comment to the appropriate departments as deemed necessary by the Community Development Director;
- 2. Review the submitted survey map and supplemental information to determine compliance with these ordinances and prepare its report, which shall include comments received from other departments;
- 3. Based on the above findings, the Community Development Director may then approve, conditionally approve, or deny the application within fifteen working days from the date a completed application was filed unless the applicant consents to an extension of the review period in writing;
- 4. Where the resulting parcel (s) do not meet the review criteria and the survey has been recorded, the town may, have a notice of code violation recorded with Apache County Recorder's Office. Nothing herein shall be construed to create a right or expectation of such approval and no building or use permit may be issued by the town until the parcel has met the review criteria. It shall be the responsibility of the landowner to remedy all deficiencies.

H. Approval. If the Community Development Director approves the application, he or she shall enter
the following certification on the approved record of survey:
I,, Community Development Director of the Town of Eagar, certify that this plat
creates a minor land division and or the combining or recombining of lots subject to and approved in
accordance with the Town of Eagar Subdivision Ordinance.






#### **PRESSURE LOSS CHART**




#### **PRESSURE LOSS CHART**


Typical Rate of Flow in Gallons per Minute (gpm)



The following Terms & Conditions apply to the BEACON® Advanced Metering Analytics (AMA) Solution, composed of BEACON AMA Software as a Service (SaaS) and ORION® Network as a Service (NaaS) with ORION Cellular endpoints sold by Badger Meter, inc. ("Badger Meter") or one of its authorized distributors to a utility or non-utility customer ("Customer") and are in addition to those found at <a href="https://www.badgermeter.com/legal-and-compliance/">https://www.badgermeter.com/legal-and-compliance/</a> and as appropriate, the BEACON General Agreement and/or BEACON Master Agreement executed by Customer.

#### **ONE-TIME FEES**

#### **BEACON ENGAGEMENT FEE**

A one-time BEACON AMA Engagement Fee, invoiced by Badger Meter or one of its authorized distributors, is required for all deployments of the BEACON AMA Solution with ORION NaaS. This fee includes setup and activation of Customer's BEACON AMA portfolio. Billing integration professional services are separate and an additional fee. Fees charged to a Customer by its utility billing vendor for an interface file are separate and are the responsibility of the Customer.

#### **SERVICE UNITS**

Recurring service fees are based on asset type and assessed monthly ("Service Units"). Asset types are identified by unique Service Unit part numbers as represented in this section. Service Units will be invoiced by Badger Meter or one of its authorized distributors.

#### **ORION NaaS SUBSCRIPTION FEE SERVICE UNITS**

Customer's deploying a BEACON AMA Solution with ORION NaaS will be assessed NaaS Subscription Fee Service Units, which include Customer's license and access to the BEACON AMA software, software updates, hosting of Customer's metering data, and technical support. NaaS Subscription Fee Service Units (68886-101, 68886-104 and 6886-201) will be assessed monthly, per eligible ORION NaaS endpoint in Customer's BEACON AMA portfolio. Such an endpoint will consume one or more Service Units each month, based on data interval and call-in frequency, and will be assessed on the 26th of each month. Service Units will be consumed for endpoints that have been activated or are more than six months past their original manufacturer ship date. Service Unit price may vary if purchase increment is changed.

#### FIXED NETWORK GATEWAY TRANSCEIVERS (if applicable)

Supply, installation, backhaul communication and maintenance of ORION® fixed network gateway transceivers deployed as part of a NaaS solution are included in the NaaS endpoint pricing and monthly subscription fee Service Units.

#### EyeOnWater® CONSUMER ENGAGEMENT

An EyeOnWater® License is included in the BEACON AMA Solution with ORION NaaS. The license includes software licensing, setup and activation of EyeOnWater consumer engagement module for NaaS accounts in Customer's BEACON AMA portfolio. The Customer is required to have appropriate data fields provided from billing software to support EyeOnWater. Fees charged to a Customer by its utility billing vendor for interface file are separate and are the responsibility of the Customer.

#### SERVICE UNIT PRICING AND PAYMENT

Customer will be required to submit a PO to Badger Meter or one of its authorized distributors for applicable Service Units. Initial Service Unit pricing will be held for the first 12-month term, then subject to change thereafter.

Service Units may be purchased in Customer-defined increments except where minimum multiple purchase increments have been stated. Reorder increments will be established at time of initial purchase and may be modified at a later date. Service Unit price may vary if purchase increment is changed.

Service Unit pricing is Net to Customer and will be involced by Badger Meter or one of its authorized distributors based on Customer-defined Service Unit purchase increments or minimum multiple purchase increments as noted. Service Unit part numbers are denoted as 68886 and have been included in this document for cross reference with Customer pricing proposal.

Service Units will be consumed on a monthly basis, as applicable to each asset type,

Service Units are non-refundable and non-transferable to another entity without Badger Meter approval.

Service Units may be converted to like-valued, or higher, Service Units of a different asset type with Badger Meter approval.

Service Units expire ten (10) years from date of purchase. Expired Service Units will be forfeited unless converted prior to expiration.

Upon termination of a Customer's BEACON AMA services, for whatever cause, unused Service Units will be forfeited if not converted to Badger Meter future purchase credit within ninety (90) days.

Failure to renew services at term expiration, or pay for services invoiced by Badger Meter or one of its authorized distributors, may result in termination of services and limited access to Customer's BEACON AMA portfolio at the discretion of Badger Meter.

Once deactivated by the network carrier, ORION Cellular endpoints cannot be reactivated.

#### REPLACEMENT OF ENDPOINTS UNDER NETWORK GUARANTEE

The following applies only to endpoints replaced under the network guarantee described in the ORION Cellular Water Endpoints Network as a Service (NaaS) warranty document (ORI-WR-03510-EN-Domestic), ORION Cellular LTE Endpoint warranty document (ORI-WR-03433-EN), BEACON AMA Managed Solution with ORION Cellular CDMA N and Fixed Network (SE) Water Endpoints warranty document (BEA-WR-02097-EN), or with ORION Cellular CDMA and Fixed Network (SE) Water Endpoints warranty document (BEA-WR-00719-EN). For those endpoints replaced under the network guarantee, the Customer shall be responsible for fees related to communication, including the most recently published replacement endpoint activation fee to initiate endpoint communication, and a minimum of 60 Service Units per replacement endpoint, 12 per year for five (5) years. Purchase fees for a minimum of 12 Service Units per endpoint will be billed at the time replacement endpoints are shipped, and will thereafter be billed annually in 12-unit increments at a minimum per endpoint.
